**Tricor Group Extends Share Registry Services to  
Financial Services Companies Manulife and ZhongAn**

We are pleased to report smooth sailing of ZhongAn’s most successful IPO in Hong Kong in September, which was 390 times over-subscribed with market valuation of HK\$ 85+ billion. Tricor, additionally, provides named company secretary service for the insurer.
